BOARD OF TRUSTEES – Regular Meeting – July 5, 2022

CALLING THE MEETING TO ORDER: The regular meeting of the Union Township Board of Trustees was called to order by President of the Board, Fred Vonderhaar on Tuesday, 7/5/22 at 6:00 p.m. at the Union Township Municipal Building. The meeting was opened with the Fiscal Officer, Shelley Lamb, taking roll call of the trustees: Fred Vonderhaar, Chris Koch, & Tony Ledford. The prayer was led by Mr. Koch. Mr. Ledford led everyone in The Pledge of Allegiance.

CITIZENS IN ATTENDANCE (IF KNOWN): Paul Redmond, Dan Stoffel, Art Perong, & Tim Wiebe were in attendance. Mr. Stoffel inquired about the possibility of “gating” the Shawhan Trails Subdivision but was told it could not be done after roads were already dedicated. Mr. Redmond complimented the police on giving Shawhan Trails more focus concerning speeding traffic.

POLICE SUMMARY: Sergeant Adams and Deputy Pangallo had nothing to report.

CHIEF'S REPORT: Chief Napier reported the fireworks presentation on the 4th of July was a success. He stated the fatal fire on Shawhan Road was still under investigation.

ROAD SUPERINTENDENT'S REPORT: Josh Sandlin was not in attendance, so the issues on Trovillo Road and Manistique Lakes will be updated when he returns.

FISCAL OFFICER'S REPORT: The Fiscal Officer presented the bills to pay, fund status, cemetery deeds, etc. thru July 6, 2022. All were signed and approved by Mr. Vonderhaar, Mr. Ledford & Mr. Koch.

NEW BUSINESS: Mr. Koch said Union Township was named the #1 place to live in the area by Cincinnati Magazine and will be featured in a future publication. Mr. Koch mentioned he spoke to a few contractors to give Union Township quotes for new fire house doors. Mr. Koch made a motion to pay the bills, seconded by Mr. Ledford. The motion was carried by all “yeas”.

Mr. Ledford made a motion to accept the minutes from the meeting held on 6/22/22, seconded by Mr. Vonderhaar. The motion was carried by all “yeas”.

Mr. Vonderhaar presented a quote from Leader Machinery Company, Ltd. for certain road repairs. Mr. Vonderhaar made a motion for Leader Machinery to do repairs on Bone, Cox-Smith, Arapaho, & Shawnee Roads for a total of \$7,125.00, seconded by Mr. Ledford. The motion was carried by all “yeas”.

Mr. Vonderhaar moved for adoption of Resolution #07052022-01 (see attached), seconded by Mr. Ledford. The motion was carried by all “yeas”.

Mr. Vonderhaar moved for adoption of Resolution #07052022-02, to proceed with the renewal of the Fire Levy (3.9 mill) that was presented by Chief Napier. Mr. Koch requested Chief Napier have more information concerning this tax levy at the next meeting before proceeding with the resolution.

ADJOURNMENT: There being no further business, Mr. Vonderhaar made a motion, seconded by Mr. Ledford to adjourn the meeting at 7:34 p.m. The motion was carried by all “yeas”. The next regular meeting will be held on Monday, July 18, 2022, at 6:00 p.m.


